### **General Provisions**

#### **Discount Codes / Vouchers**

It is the sole responsibility of the registrant to apply any valid discount code or voucher at the time of registration.

If a registration is completed without applying a discount code or voucher, no refund or adjustment will be made.

#### **Transaction Fees**

Any applicable transaction costs, including but not limited to Stripe processing fees, bank transfer charges, or intermediary banking fees, will be deducted from the total refundable amount.

#### **Refund Payment Method**

Refunds can only be made to the original account, card, or payment method used for the initial transaction.

Refunds cannot be made to any other bank account, card, or third-party payment method under any circumstances.

#### **Time Calculation**

All time periods stated in this policy refer to calendar days prior to the event start date.

#### **Refund Processing Time**

Approved refunds will be processed within 7 to 10 business days.

However, depending on the recipient's bank or payment provider, it may take up to 1 week to 10 days for the refunded amount to appear in the account.

#### **Currency**

Refunds will be issued in the original payment currency.

Owlypia is not responsible for any differences caused by exchange rate fluctuations or intermediary financial institutions.

#### **Special Cases**

**Force Majeure:** Refunds in cases of force majeure will be determined at the sole discretion of the Owlypia Board.

## Owlypia Globals

### Visa Refusals

Refund requests must be supported by an official visa refusal letter.

Verbal statements or informal communication will not be accepted as sufficient evidence.

### Group Registration Discount

Students must register as part of a group via an authorised supervisor to qualify for group discounts.

Individual registrations made outside this process are not eligible for any refunds relating to group discount discrepancies.

### Refund Limitation Explanation

Refund amounts may be less than the total registration fee due to pre-committed operational costs associated with the event.

In preparation for the Owlypia Global rounds, arrangements are made in advance on behalf of participants, including but not limited to travel logistics, accommodation reservations, local transportation, venue bookings, and catering services. These arrangements often require non-refundable deposits or advance payments to third-party service providers.

In the event of a participant's cancellation, a portion of the registration fee may have already been allocated to such third-party services and may not be recoverable by Owlypia. As a result, full refunds may not be possible in all cases.


## SECTION 22 - DISCOUNT CODES
